A motion to adopt the ordinance, resolution or order must be made in the following form. Discussion held by the board.

Erika Smiley made a motion to increase by adoption of a tax rate of 0.098097, which is effectively an 11.23 percent increase in the tax rate. Dan Dronberger seconded the motion with unanimous approval of the board.

To Approve payment of Houston Chronicle invoice for publication of Notice of Public Hearing on Tax Increase.


Discussion held by the board.
